

**Waiver Of Liability, Assumption of Risk and Indemnification Agreement for
Participation in Catoosa County Recreational Sports as a Minor**

1. In consideration of Catoosa County permitting participation of Minor, the undersigned Parent or Guardian agrees to hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Catoosa County, and its Board of Commissioners, officers and employees from any and all liability for any and all damages, losses or injuries to persons or property, which arise out of, or occur during or are the result of participation.
2. To the best of my knowledge, I am not aware of any physical disability or health-related reasons or problems that would preclude or restrict my child's participation. I am fully aware of the risks and hazards associated with my child's participation in recreation activities, and I understand that certain, inherent risks cannot be eliminated regardless of the care taken to avoid injuries. I understand that specific risks vary depending on the level and nature of the activity, and can range from minor personal injuries such as scratches, bruises, and sprains, to major injuries such as eye injuries and back or joint injuries, or catastrophic injuries resulting in paralysis or death. I understand that my child's participation is purely voluntary, and, notwithstanding the risk of injury to my child or his or her property, I consent to my child's participation, and I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, AND PERSONAL INJURY, INCLUDING DEATH, that may be sustained by my child as a result of his or her participation in the recreational programs.
3. My child has sufficient health insurance coverage to provide for any medical expenses that may directly or indirectly result from his or her participation in the recreational programs. I understand that Catoosa County does not take responsibility for the payment of any such medical expenses.
4. I agree to INDEMNIFY AND HOLD HARMLESS, Catoosa County, it's Board of Commissioners, officers and employees from any and all claims, actions, costs, expenses, damages and liabilities, including attorney's fees that may be incurred as a result of my child's participation in recreational programs.
5. I understand that this Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Georgia, and that if any portion hereof is held invalid, it is agreed that the remaining terms shall continue in full legal force and effect.
6. Nothing in this Agreement shall be construed to waive, limit, or otherwise modify any governmental immunity that may be available to the State of Georgia, Catoosa County, its Board of Commissioners, officers and employees under O.C.G.A. § 36-1-4 or any other statute or regulation providing sovereign immunity or official immunity.
7. By my signature below, I acknowledge and represent that I have read this WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT, fully understand and accept its terms, and sign it voluntarily.
